# **Angela Shores named North Carolina Main Street Champion**

Angela Shores, owner of Adventure Bound Books in Downtown Morganton, was recognized as a North Carolina Main Street Champion by the N.C. Department of Commerce and N.C. Main Street Program at a statewide conference in March.

North Carolina Main Street Champions are individuals that work and advocate for revitalized downtowns. The N.C. Department of Commerce and N.C. Main Street program began recognizing Main Street Champions in 2000.

A total of 766 Champions have been recognized by the North Carolina Department of Commerce over the past 20 years.

The Morganton Main Street Program nominated Shores as its 2019 Main Street Champion. Adventure Bound Books opened in Morganton in June of 2018 under the direction of Shores.

"Angela has been an incredible addition to our downtown merchant community," said Main Street Director Sharon Jablonski. "She immediately got involved with our development efforts, and runs a business that is much-loved by the community. She is innovative in her offerings and deeply cares about the business she runs. We are

thankful to have her in our City."

Since opening in 2018, Shores has been involved with downtown and Morganton Main Street efforts. She quickly joined

the Downtown Development Association, joined the steering committee for the Courthouse Square redevelopment, got involved with the Burke Arts Council Third Thursday Art Crawls, and, among other things, she has taken promotional retail events to the next level and become a champion among Morganton's retailers. A few of the programs Shores has conducted at Adventure Bound Books include: weekly story-time, adult book clubs, author meet and greets, poetry nights, and writing contests. As one of Morganton's newer businesses, Shores has highlighted the path to what it takes to be a champion.

## City offering bill payment plans

The City of Morganton is now working with citizens to make payment plans for utility bills to lessen the economic burden on our customers bearing the brunt of the COVID-19 crisis.

The payment plans will allow customers to pay parts of their utility bills

over a longer period of time, instead of being required to pay the entirety of their bill at once.

The City suspended late fees and disconnection of utility services for nonpayment of bills beginning March 20, and this practice remains in effect. However, debts and outstanding charges are not being forgiven, so it is important that customers pay as much as they can afford. Utility debts and outstanding charges cannot be forgiven by law.

# New dog park now open at Catawba River Soccer Complex

There's a new place in Morganton for your larger furry friends to run and play. A new dog park for dogs 25 pounds and up opened at the Catawba River Soccer Complex on Friday, April 24.

The new dog park opened as an extension of the existing park at the soccer complex for dogs under 25 pounds. This helps separate breeds of different sizes, and ensure dogs of all sizes can enjoy a day at the park.

The new dog park offers more than an acre of space for dogs to run and play. Its construction was planned as part of Phase III of the Catawba River Soccer Complex's expansion. It was made possible through a Parks and Recreation Trust Fund Grant, as well as a number of private donations from the community.

The park is open daily from sunrise to sunset.

The following rules are in place at the park:

- Dogs must have tags displaying current vaccines, registration and ownership.
- Choke, spike, pinch or prong collars are strictly prohibited.
  - Children under 14

are not allowed without an adult.

- -Aggressive dogs are strictly prohibited.
- In-heat females are not allowed.
- No food is allowed inside the dog park.
- Owners must pick up after pets.
- -Use of tobacco or vaping products is prohibited.



## **Community Appearance Advisory Commission celebrates Arbor Day**

Members of Morganton's Community Appearance Advisory Commission recognized Arbor Day in North Carolina, and in the United States, by having a tree planted at Morganton Public Safety Station 2 in early March.

The City's Public Works Department planted the tree, and members of the advisory commission gathered during their regular meeting on March 10 to dedicate the tree at the public safety station.

North Carolina Arbor Day was recognized on March

20, and Arbor Day in the U.S. was recognized on April 24.

A Yoshino Cherry tree was planted at the station. The tree is considered a medium-sized shade tree that blooms in March and April each year. The tree can grow to be 30 to 40 feet tall, and is
